About in Lieu of Transportation Payment

In accordance with RC 3327.02 of the Ohio Department of Education, the board of education of a city exempted village or local school district may determine that it is impractical to transport a pupil who is eligible for transportation to and from a school under section 3321.01 of the Revised Code.

If a student who lives in the Columbia Local School District boundaries chooses to attend a chartered nonpublic school, they may be entitled to Payment in Lieu of Transportation if the Columbia Local Schools Board of Education deems it impractical to transport those students to and from their chartered nonpublic school. This applies to students in grade K through 12 when the chartered nonpublic school is within 30 minutes travel time of the school in which the student would attend if they attended the Columbia Local Schools.

To obtain Payment in Lieu of Transportation, it is the responsibility of the parent or guardian to notify the Columbia Schools each year by completing an online application. You must apply each year. The deadline for application is September 10, 2021. No applications received after that date will be accepted.

A separate application must be completed for each child in the family.

At the end of the school year, the District will ask you to verify transportation for the school year and provide us with proof of automobile insurance. Reimbursements will be issued in the month of June.

Again, unless you have requested Payment in Lieu of Transportation by September 30, we cannot provide reimbursement. There can be no exceptions.
